Droplet Precautions

It was noted that visitors do not routinely follow the droplet precautions by wearing appropriate PPE.

- With flu at its peak, we need to put patients in droplet precautions whenever we have a degree of
 suspicion for influenza. We should also use droplet precautions for patients with illnesses that cause
 cough and fever. If they are sick enough to come to the Emergency Department, Urgent Care or to
 be admitted, they may have something contagious.
- Nursing should educate families and visitors with patients to wear masks if droplet precautions are
 in place. Simply say, "We are well into cold and flu season. Please wear these masks while you are
 in your loved one's room for everyone's protection, and sanitize your hands on arrival and when
 leaving."
- We also need to ensure we put a surgical mask on our patients who have cough and fever when we transport them outside their room. This will help contain their germs where they are generated.

What is Ransomware?

Ransomware stops you from using your PC. It holds your PC or files for "ransom". This page describes what ransomware is and what it does, and provides advice on how to prevent and recover from ransomware infections.

What does ransomware do?

There are different types of ransomware. All of them will prevent you from using your PC normally, and they will all ask you to do something before you can use your PC.

They can target any PC users, whether it's a home computer, endpoints in an enterprise network, or servers used by a government agency or health care provider.

Ransomware can:

- Prevent you from accessing Windows.
- Encrypt files so you can't use them.
- Stop certain apps from running (like your web browser).

Ransomware will demand that you pay money (a "ransom") to get access to your PC or files. We have also seen them make you complete surveys. There is no guarantee that paying the fine or doing what the ransomware tells you will give access to your PC or files again.

To be eligible for the short-term disability plan, the employee must be assigned to work at least 64 hours per pay period. For the Colonial cancer plan, the employee must be assigned to work 40 hours per pay period.




